Gigaclear's Wholesale Access Agreement is issued to RSP's as part of the onboarding process. All products and prices will be benchmarked on an annual basis All prices quoted are monthly costs exclusive of and subject to VAT

Non-Standard Installations – Gigaclear will notify the RSP of any additional charges prior to installation following a survey. Early Termination – Should an RSP wish to terminate within the minimum term, Early Termination Charges will apply (respective monthly charge multiplied by length of term remaining).

Gigaclear Wholesale Revenue Volume Rebate

Gigaclear will provide a rebate percentage* based on the net wholesale Subscription Charges paid to Gigaclear upon a Partner meeting the respective rebate amount criteria targets listed below. The rebate is calculated in arrears on a quarterly calendar basis and will be applied as a credit to the Partner's next invoice. At the end of each calendar quarter, Gigaclear will only notify the Partner when a rebate is due.

Gigaclear Early Termination Charges (ETC)

As a Wholesale Partner, Broadband services provided by us are for a minimum term defined in this pricelist for each service, the term starting from the service Activation Date. This term is the length of time that you commit to retaining and paying for the service. If you decide to end a service with us during the minimum term period, Early Termination Charges may apply. This is because you will be ending the contract with us early. The Early Termination Charges will not be more than the charges you would have paid for the services for the remainder of the minimum term period and will include VAT for the remaining period. Early Termination charge is based on the monthly subscription cost x the number of months remaining under the subscription Early Termination Charges apply after 1 months' notice has been provided by you. So, for example, if you wish to cancel with 6 months of the minimum term remaining, you will need to provide us with 1 months' notice, during which you will retain (and continue to pay for) the services after which you will pay Early Termination Charges equivalent to the remaining 5 months.

Exceptions to this ETC: 1/ Where the end residential customer is vacating the property and moving to a property that is not on the Gigaclear network, no ETC will be payable, but we may require evidence of the move. 2/ If the end customer is moving to another property on the Gigaclear network and takes up the same or a higher value service within 1 month of leaving the previous property, no ETC will be payable, however, the service contract period will be restarted.
